In view of the above, information provided by the financial statements of different NGOs is not uniform or comparable. This has given rise to confusion and misunderstanding among the users of financial information provided by NGOs

2. SCOPE

- ✓ The contents of today's discussion are applicable to following NGOs, whether community based, national or international, having their operations in India:
 - Societies registered under the Societies Registration Act 1860;
 - Public Trusts;
 - Trusts registered under State enactments; and
 - Other NGOs set up under any other Central/State Enactments.
- ✓ Today's discussion specifically excludes from its scope, Section 8 Companies, Co-operative Societies, Local Bodies, Political Organizations and Private Trusts.
- ✓ This report focuses on presenting a standardized framework for preparation and presentation of financial statements in NGOs, using sound accounting principles pertaining to recognition, measurement and disclosures. Therefore, the requirements of various Acts including the Income-tax Act and the Foreign Contribution (Regulation) Act, do not form part of this discussion.
