Elections for the Year 2026-2027

Notice-cum-Information

The Managing Committee of the Pimpri Chinchwad Branch of WICASA comprises 2 members nominated by the Managing Committee of the **Pimpri Chinchwad Branch of WIRC of ICAI** and 6 members elected by the Members of the Pimpri Chinchwad Branch of WICASA from amongst its members.

Some of the relevant rules regarding eligibility to vote, eligibility to contest for election, mode of filling nomination, etc., are given below:

- 1.** Any student who is a member of the Pimpri Chinchwad Branch of WICASA as on **1st March, 2026**, is eligible to vote in the election, provided he continues to remain a member on the date of the election. For this purpose, any student undergoing articleship training in Pimpri Chinchwad will be considered a member of the **Pimpri Chinchwad Branch of WICASA**.
- 2.** Any member eligible to vote in the election can contest in the election provided the unexpired period of his/her articleship training as on **1st March, 2026**, is not less than one year.
- 3.** A member desiring to contest the election shall submit a nomination form duly signed by him/herself and by a Proposer and a Seconder, who shall be persons entitled to vote in the election. The Nomination form will be available at ICAI Bhawan, Nigdi and also available at www.pimprichinchwad-icai.org from **Monday, 23rd February, 2026**, during office hours.
- 4.** Every candidate for election shall pay Rs. 10/- (by Gpay/Cash/Bank Draft only) to the office of the Pimpri Chinchwad Branch of WIRC of ICAI, along with the Nomination Form, which shall not be refundable in any case. Completed Nomination Form shall be accepted up to 5 p.m. on **Wednesday, 25th February, 2026**, at ICAI Bhawan, Nigdi, Pune.
- 5.** List of valid nominations will be displayed at ICAI Bhawan, Nigdi, Pune on Monday, **27th February, 2026 by 5 pm**, and the last date and time for withdrawal of nomination will be Thursday, **28th February, 2026 by 5 pm**.
- 6.** The final list of Nominations will be displayed at ICAI Bhawan, Nigdi, Pune on Thursday, **28th February 2026, after 5 pm**.
- 7.** The elections shall be held if more Nomination forms are received than the number of Vacancies i.e. 6. The election shall be by way of poll of members on **Saturday, 7th March, 2026** from 9:30 am to 5:30 pm at "ICAI BHAWAN", Nigdi, Pune 411044. Preferential Voting will be there in case of an election. No proxy will be allowed.

8. The names of all candidates elected shall be announced at the meeting by the Election Officer, and his decision and declaration shall be final.
9. Student Members are requested to bring along their Student Article Identity Card/copy of letter of Articleship Registration / Eligibility form duly signed by the principal, as proof of their eligibility to vote. Ballot paper will not be issued to any student unless the eligibility form is complete in all respects and appropriate photographic identification is available.
10. The Election Officer will be appointed to receive, scrutinize and finalise the nominations and to conduct the election in accordance with Appendix V of the Chartered Accountants Regulations, 1988.
